## Statement to REACH - REGULATION (EC) No 1907/2006

The new EU regulation concerning the Registration, Evaluation, Authorisation and Restrictions of Chemicals (REACH) has been enforced since June 2007

From this point onward, various deadlines and obligations apply, e.g. registration of chemical substances, Information in the supply chain etc.

We are engaged in an active dialogue with our suppliers and we assume that all substances used by our company, total amount more than 1 tonne per year, will be registered by our suppliers who send us documents for verifying. We are about to take the necessary steps to secure the future production and marketing of our individual products or product groups, which means in the beginning to start with controlling the registration of all substances we need for our products.

Preparations/mixtures manufactured by our company do not need to be registered in their form as preparations/mixtures, only the substances as components of the preparations/mixtures have to be registered.

The European Chemicals Agency (ECHA) is updating the candidate list of substances of very high concern (SVHC) in accordance with REACH Article 59
